



Equality and Diversity Policy

Rationale

We believe that at Trent CE Primary School attitudes and behaviour must be based on the fact that every member of the school community is of equal importance in the eyes of God. This policy explains our vision and commitment to equality of opportunity and the respect for diversity as a provider of quality experiences for the children and adults who attend our school.

Our Vision and Values

Trent CE Primary is committed to the vision of having a safe, cohesive, healthy and inclusive community. This vision is guided by the core values of:

- **Love** – *seeking what is best for others even at the cost of oneself*
- **Justice** – *protecting, upholding dignity and worth, being inclusive always*
- **Forgiveness** – *restoring relationships, growing in maturity and goodness*
- **Generosity and Gratitude** – *giving, sharing time and skills, openness, saying 'thanks'*
- **Truth and Integrity** – *sincerity and honesty, true to oneself*
- **Hope** – *the habit of positive expectation to transform lives*

In addition we act to:

- Uphold the basic right of every individual to be treated and valued equally
- Value the unique diversity of every individual which may include, race, gender, class, age, disability, and sexuality
- Eradicate false beliefs and discriminatory practices which create negative feelings, cause frustration and limit individual potential
- Promote good relations in our engagement with partners and local community

We count on the support of pupils, parents, staff, governors and the wider community to ensure that all people are valued and treated fairly in our diverse multi-cultural society.

Procedures

In enforcing and embedding equal opportunities and respect for diversity, we will:

- Monitor and record all racist incidents
- Deal with any reported 'racist incident' in accordance with the procedures outlined in our school Behaviour Policy
- Deal with any breaches of 'equal opportunity' in accordance with the procedures outlined in our school Behaviour Policy and Staff Conduct policy
- Ensure that staff are trained in being aware of, understanding and valuing the importance of equality and diversity and in the 6 standards.
- Provide a procedure where staff, children or parents can formally raise serious concerns about a breach of this policy
- Ensure that recruitment of staff is based on the sole basis of work criteria and the applicants abilities and individual merit
- Report annually to the Governing Body the number of racist incidents and a breakdown of Equal Opportunity incidents under the 6 standards.
- Report annually the number and self defined ethnic identity of any 'excluded' pupils or any other significant categories
- Update annually our 'Equality and Diversity Action Plan' (Appendix 1) which will ensure that we monitor and meet the Standards for Equality in all areas of school life.

A duty to promote community cohesion

We will use the principles outlined in this policy to work towards a cohesive community in which:

- All members enjoy a sense of belonging
- The different backgrounds of people are valued and appreciated
- All enjoy equal access to the opportunities life presents
- We work towards developing relationships between people from diverse backgrounds in school and the local community

Whistleblowing

Should any member of the school community feel that his or her rights to an equal opportunity have been disregarded then the following procedures as outlined in our **Whistle Blowing** Policy will apply: A child – should report his/her concerns to any adult employed by the school, who will then follow the procedures outlined in the school **Behaviour Policy**

An adult – should report his/her concern to the Headteacher or to a Parent Governor, who will investigate the complaint and if necessary take measures to redress the situation.
